#### **Community Vision**

The General Plan Update is an opportunity to reaffirm and refine the Community's Vision for itself:

- Quality of life
- Preservation of Open Space and Agriculture
- Innovation and Sustainability
- Vibrant economy
- Jobs and housing

#### WHY IS THE GENERAL PLAN IMPORTANT?



#### **Comprehensive in Scope**

The General Plan serves as the City's 'playbook' for land use and planning decisions relative to:

- Land Uses (residential, commercial, industrial, business parks, open space, etc.)
- Infrastructure Planning (roads, water, sewer, etc.)
- Public Services (police, fire, parks, libraries, cultural activities, etc.)
- Resource Conservation (clean air, sensitive habitat, waterways, groundwater, agriculture, etc.)

#### WHY IS THE GENERAL PLAN IMPORTANT?



- Strategically identifies budget and capital investment priorities based on realizing the General Plan's vision
- Serves as a management tool used by staff and decisionmakers
- Provides guidance regarding priorities for City services including the Capital Improvement Program, Parks Planning, and Utilities Master Plans
- Streamlines development that is consistent with City's vision
- Compliance with State laws and grant eligibility

  - Housing Element updated in 2017 (currently being updated via a separate process)
- Numerous changes to State law and Local Conditions



# LAND USE MAP

- The Land Use Map assigns a designation to every parcel within the City limits, the City's Sphere of Influence (SOI), and the larger Planning Area.
- Determines what can be built, and where
- Similar to the Zoning Map, but at a more general level of detail
- The GP Update provides an opportunity to further refine key areas within and around the City, make adjustments, and plan for future growth and resource conservation





### **VISION STATEMENT**




The General Plan Update should be guided by a Vision Statement. The Vision Statement should be concise and clear, and should articulate the overarching goals of the community. For example:

Our city is a desirable community to live, learn, work, and play. Our city has maintained its small-town character and feel, while growing into a healthy and vibrant mid-size city that celebrates its surrounding environmental resources, agricultural heritage, and cultural diversity. Our community is healthy, safe and family-oriented, with thriving schools, parks, shops, entertainment, and businesses.

Working individually, or as a group, please develop a Vision Statement for the Atwater General Plan Update. Your Vision Statement should be 3-4 sentences long, and should include your most important guiding principles.

### LAND USE MAPPING
